#### **RG 349: Dorothy M. Hamm Papers**

Dorothy Hamm moved into a home she built with her husband Leslie in the High View Park neighborhood in Arlington in 1950. At the time, the historic black neighborhood, established by newly freed enslaved people after the Civil War, was literally walled off from surrounding white communities. An eight-foot high fence, put up by nearby white homeowners, lined three sides of the neighborhood. The walls finally came down after Hamm and others led the fight to desegregate Arlington's public schools. Over the next two decades, Dorothy Hamm's name became synonymous with the civil rights movement in Arlington.

Hamm became one of the plaintiffs in a civil suit, filed in 1956, that eventually forced Virginia to integrate its public schools after the landmark Supreme Court decision *Brown v. Board of Education*, which declared segregated schools illegal. She revealed in an oral history in 1986 that she filed because "I felt that with the Supreme Court's decision my two sons would have an opportunity to attend Stratford, an integrated school....However, almost 2 years had passed, they still had not been permitted to attend; and this is why I really got involved." In 1959, four black seventh-grade students entered Arlington's Stratford Junior High, making it the first school in Virginia to desegregate. Seven months later, Hamm's son finally ended his long commute to Arlington's black middle school and attended Stratford Junior High, located near the Hamm household.

Hamm's fight did not end with public schools. She also served as a plaintiff in a civil action suits that integrated public school athletic program and eliminated the poll tax and race designation on voting records in Arlington County. In the early 1960s, she picketed theaters and stores in Arlington with other activists, which did not allow black patrons or employees. Such establishments opened their doors to African Americans soon after. In 1965, she became the first African American elected to a political party, representing the Woodlawn precinct for the Democratic Committee in Arlington. This was at the tip of her long career as a political official in Arlington. She spent nearly three decades as an officer of elections for Arlington County.

Preserving local African-American heritage became Hamm's later efforts. As President of the John M. Langston Citizen's Association, she fought to clean-up and preserve the High View Park neighborhood. She also wrote many plays about local African-American history, performed at several county events. Though she returned to her hometown in Caroline County, VA in 1987, Hamm's influence in Arlington will continue for years to come.
